Dear Judge Sullivan:

This Office represents defendants United States Department of Health and Human Services ("HHS") and Alex M. Azar II in his official capacity as Secretary of HHS (collectively, the "Defendants") in the above-referenced matter, in which plaintiffs assert causes of action pursuant to the Administrative Procedure Act, 5 U.S.C. § 701 et seq. We write on behalf of all parties to request an extension of certain deadlines set forth in the Stipulation and [Proposed] Order ("Stipulation") that the Court adopted in its Order of May 3, 2018. See Dkt. No. 22. A copy of the parties' proposed Amended Stipulation of Stay and [Proposed] Order ("Amended Stipulation") is attached, and also has been submitted to the Orders and Judgments Clerk for review.

The parties have proceeded pursuant to the terms of the Stipulation. However, as set forth in the attached proposed Amended Stipulation, the parties have determined that additional time is necessary for Defendants to produce a complete draft administrative order and for the States to comment on that order. Accordingly, the Amended Stipulation proposes to modify certain dates and deadlines. The parties have agreed that the Amended Stipulation shall supersede the original Stipulation only if the Court extends the date by which the parties may request restoration to the Court's docket—currently set for August 1, 2018, see Dkt. No. 22—to September 21, 2018.

In addition, the States respectfully request that the Court amend its Order of May 3, 2018, to rescind the dismissal of this action and instead provide that this action will be held in abeyance pending further order of the Court. Defendants take no position on that request.

The parties reached agreement as to the terms of the proposed Amended Stipulation today.
