Motion to Strike Defendants' Experts Golden and Truffer and Brief in Support (ECF Nos. 70–71)

for October 12, 2017. ECF No. 76. The Jewish holiday of Shemini Atzeret-Simchat Torah begins

at sundown on October 11, 2017 and continues through nightfall on October 13, 2017.

Undersigned counsel, Ms. Straus Harris, who has had primary responsibility for this case since

April 2016 and expects to present argument for Defendants at the hearing, will be unavailable due

to the Jewish holiday.

2. On September 29, 2017, undersigned counsel conferred with Mr. Austin Nimocks,

counsel for Plaintiffs, who indicated that Plaintiffs consent to Defendants' motion to continue the

hearing. Mr. Nimocks advised that he will be out of the office on business-related travel from

October 16, 2017 through October 20, 2017, and asked that in their motion to continue the hearing,

Defendants request a hearing date on October 25, 2017 or later, to allow Mr. Nimocks time to

prepare for the hearing following his return from his scheduled travel.<sup>2</sup>
