UNOPPOSED RENEWED MOTION TO CONTINUE HEARING

By and through undersigned counsel, Defendants hereby renew their motion that the Court continue the hearing in this matter until October 25, 2017 or thereafter at the Court's convenience. Undersigned counsel conferred with counsel for Plaintiffs, who do not object to this motion. Because there is good cause for the request and no party will be prejudiced, the Court should grant the motion.

1. As the Court's Order noted, in support of their Consent Motion to Continue Hearing (ECF No. 77), Defendants cited the unavailability of undersigned counsel, Ms. Straus Harris –

who has had primary responsibility for this case since April 2016 and expects to present argument for Defendants at the hearing – on the original hearing date due to the Jewish holiday of Shemini Atzeret-Simchat Torah, which begins at sundown on October 11, 2017 and continues through nightfall on October 13, 2017.

- 2. In their Consent Motion to Continue Hearing, Defendants further noted, albeit in a footnote, that Ms. Straus Harris will also be out of the office on religious leave for the Jewish holiday of Sukkot, which begins at sundown on October 4, 2017 and continues through nightfall on October 6, 2017. During the holidays of Sukkot and Shemini-Atzeret-Simchat Torah, the Jewish religion prohibits the performance of certain activities associated with creative work, including writing and the use of electronic devices. Undersigned counsel regrets that Defendants' Consent Motion to Continue Hearing was not more clear in explaining the extent and effect of Ms. Straus Harris's absences for these Jewish holidays.
- 3. In addition to Ms. Straus Harris's religious leave on Thursday, October 5 and Friday, October 6, the federal government will be closed on Monday, October 9 in observance of Columbus Day.
- 4. Accordingly, due to both Ms. Straus Harris's religious leave and the closing of the federal government, there are only two business days between the Court's Order and the hearing date. As a result, the current hearing schedule permits no feasible way for undersigned counsel to consult with the client agencies and prepare for the hearing which, as the Court is aware, will cover four separate motions and a record of several thousand pages.
- 5. As Defendants explained in their Consent Motion to Continue Hearing, Defendants requested that the hearing be continued until October 25, 2017 or later to allow counsel

for Plaintiffs, Mr. Austin Nimocks, adequate time to prepare for the hearing following his returned from scheduled business-related travel from October 16, 2017 through October 20, 2017.

- 6. On October 3, 2017, undersigned counsel conferred with Mr. Nimocks, counsel for Plaintiffs, who indicated that Plaintiffs have no objection to Defendants' renewed motion to continue the hearing.
 - 7. A proposed order is attached.
