**ORDER**

Before the Court are Plaintiff States' Motion for Summary Judgment and Brief and Appendix in Support (ECF Nos. 53–54), filed January 6, 2017; Defendants' Motion for Summary Judgment and Response in Opposition to Plaintiff States' Motion for Summary Judgment and Brief and Appendix in Support (ECF Nos. 62–63), filed June 5, 2017;<sup>1</sup> Plaintiff States' Reply in Support of Plaintiff States' Motion for Summary Judgment and Response in Opposition to Defendants' Motion for Summary Judgment (ECF No. 66), filed June 23, 2017; and Defendants' Reply Brief in Support of Defendants' Motion for Summary Judgment (ECF No. 67), filed July 13, 2017.<sup>2</sup>
