## DECLARATION OF LINDA WESP, MSN, RN, APNP, FNP-C, AAHIV-S

- I, Linda Wesp, MSN, RN, APNP, FNP-C, AAHIV-S, declare as follows:
- I am a Family Nurse Practitioner/Advanced Practice Nurse Prescriber (APNP)
   (WI Lic. # 6596-33) with a specialization in transgender care. I submit this declaration in my capacity as the primary care provider of Marie Kelly, a plaintiff in the above-captioned matter.
- 2. I earned my nursing degree from Loyola University Chicago in 2000 and I earned my master's degree in nursing (MSN) from University of Illinois at Chicago in 2006. I am a Registered Nurse (RN) (WI lic # 223928-30), Board Certified Family Nurse Practitioner (FNP-C) (#F0706072), and a Certified HIV Specialist (AAHIVS).
- 3. I am currently a PhD candidate in Nursing at the University of Wisconsin-Milwaukee, College of Nursing, where I am focusing my research and scholarship on transgender health.

- 4. I am also a member of the World Professional Association for Transgender Health's (WPATH) and I am currently a contributing co-author for the upcoming Eighth Version (in progress) of the *Standards of Care for the Health of Transsexual, Transgender, and Gender-Nonconforming People* ("WPATH SOC"). Specifically, I am contributing the chapter titled, "The Role of Primary Care in Gender Health." I am also a member of the Medical Advisory Board at University of California, San Francisco (USCF) Center of Excellence for Transgender Health and I was a contributing author for their publication, *Guidelines for the Primary and Gender-Affirming Care of Transgender and Gender Nonbinary People*.
- 5. More complete information regarding my professional background, experiences, publications, and presentations are provided in my curriculum vitae, attached to this declaration as Exhibit A.
- 6. I currently practice at the Greater Milwaukee Center for Health and Wellness in Glendale, Wisconsin. I provide primary care to approximately 175 transgender, gender non-conforming, and non-binary adults. I prescribe and supervise gender-confirming hormone treatments for transgender patients with gender dysphoria, including patients that have sought and been denied gender-confirming surgeries. I also provide general primary care, including HIV prevention and management.
  - 7. Many of my patients, including Ms. Kelly, are Wisconsin Medicaid beneficiaries.
- 8. I have been Marie Kelly's primary care provider at the Greater Milwaukee Center for Health and Wellness since January 2017.
- 9. Ms. Kelly is a transgender woman who, since before I started treating her in 2017, has lived as a woman in accordance with her female gender identity. When I first met Ms. Kelly, she had already been diagnosed with Gender Dysphoria, and her previous primary care provider

at Sixteenth Street Community Health Center, had already prescribed her hormone therapy (Estradiol and Spironolactone).

- 10. As her primary care provider, I determined that Ms. Kelly would benefit from continuing her hormone therapy to treat her gender dysphoria. Ms. Kelly has responded well to this treatment.
- 11. As my patient, Ms. Kelly and I have discussed her desire for gender-confirming surgeries, including genital reconstruction surgery (orchiectomy and vaginoplasty) and female chest reconstruction (breast augmentation), to treat her gender dysphoria. We have also discussed her desire for facial hair removal through electrolysis.
- 12. In my professional medical opinion, Ms. Kelly meets the criteria set forth in the WPATH SOC for receiving gender-confirming surgeries as medically necessary treatment for persistent gender dysphoria, including genital reconstruction and female chest reconstruction.
- 13. I understand that Ms. Kelly has not pursued these surgeries because of her knowledge that Wisconsin Medicaid excludes them from coverage and her inability to pay for the surgeries herself. However, I am willing to provide her with letters of support stating my professional opinion that she meets the criteria for and is eligible to obtain those surgeries.
- 14. It is my professional opinion that these surgeries are medically necessary and would treat Ms. Kelly's gender dysphoria, enhance her quality of life, and improve her mental health.
- 15. From my professional experience working as a health provider for transgender patients, for the individuals, like Ms. Kelly, who need surgery to treat their gender dysphoria, the inability to access these treatments causes significant distress in their lives. The distress then

ripples through all aspects of their life, from not wanting to socialize due to anxiety, to not being

able to get a job, to being attacked or constantly worrying about their safety.

16. As a medical provider, I find it incredibly frustrating to know the exact procedure

that would help treat my patients, but be unable to obtain that treatment for them because of

Wisconsin Medicaid's exclusion. Because the State has categorically limited my ability to

provide my patients with the care they need, I then spend hours trying to provide them with other

treatments - treatments that I know will not fully cure their gender dysphoria. Simply put,

eliminating the exclusion would allow me to provide my patients with better medical care.

Specifically, it is my professional opinion that eliminating the exclusion would benefit all of my

transgender patients on Wisconsin Medicaid seeking gender-confirming treatments for gender

dysphoria.

I declare under penalty of perjury under the laws of the United States that the foregoing is
