**JOINT STATUS REPORT AND REQUEST  
TO CONTINUE STAY OF PROCEEDINGS**

On January 2, 2019, at the request of the parties, the Court stayed this case until the disposition of the petitions for a writ of certiorari filed before the United States Supreme Court in *Land of Lincoln Mutual Health Insurance Company v. United States* and *Moda Health Plan, Inc. v. United States*. Dkt. 19. On June 24, 2019, the Supreme Court granted petitions for certiorari in the *Land of Lincoln* and *Moda* cases and the companion case, *Maine Community Health Options v. United States*. On July 1, 2019, the Court required the parties to submit a joint status report by July 12, 2019, “stating their respective views regarding whether the stay of proceedings in this matter should continue, pending resolution of *Land of Lincoln* and *Moda*.” Dkt. 20.

In order to conserve the resources of the parties and this Court, the parties respectfully request that the Court continue the stay in this case until the Supreme Court has issued an opinion in *Moda*, *Maine Community Health*, and *Land of Lincoln*. The parties propose that they be required to file a status report with this Court within 30 days after the Supreme Court has issued its opinion.
