Plaintiff-Appellee State of Wisconsin submits this letter under Fed. R. App. P. 28(i) to notify the Court that it joins and adopts portions of the brief filed by the States of Texas, Kansas, Louisiana, Indiana, and Nebraska. Specifically, the State of Wisconsin, as Appellee, joins and adopts by reference the following sections of the Argument, as specified:

- Sec. I's legal argument that the ACA exempts states providing Medicaid through a managed-care model from paying the HIPF.
- Sec. II.A's legal argument that the States have standing in this lawsuit because they sustained an injury due to the Certification Rule, and their injury is at least partially redressable by the relief the District Court ordered in this case. Because Wisconsin is not a State Appellant, it does not join the reference in footnote 10.
- Sec. II.B's legal arguments, with the exception of the State Appellants' argument in footnote 12.
- Sec. III.B's legal arguments that the Certification Rule improperly grants a private entity the authority to prescribe the rules by which States' MCO contracts are judged and to certify compliance with those rules. Because Wisconsin is not a State Appellant, it does not join any references to the State Appellants' arguments in this section.

Given that Wisconsin makes no independent arguments in this case, Wisconsin waives its right to oral argument.
