Ehrlich, and the exhibits annexed thereto, plaintiffs by their undersigned attorneys will move this Court, on a date and at a time to be determined by the Court, at Courtroom 11A, Daniel Patrick Moynihan United States Courthouse, 500 Pearl St., New York, NY 10007-1312, for an order, pending a final judgment in this action, preliminarily enjoining Defendants' (i) application of the revisions published on January 3, 2018 to the public charge guidelines in the Department of State's Foreign Affairs Manual, 9 FAM 302.8-2, (ii) adoption of the Interim Final Rule, 84 Fed. Reg. 55,011 (Published

Oct. 11, 2019), as a final rule, and (iii) implementation of the “Presidential Proclamation Suspending the Entry of Immigrants Who Will Financially Burden the Health Care System,” 84 Fed. Reg. 53,991 (Published Oct. 9, 2019); and (iv) such additional relief as the Court considers just.
