**DEFENDANT RICARDO RODRIGUEZ, JR.'S UNOPPOSED MOTION FOR
EXTENSION OF TIME TO FILE RESPONSE**

Defendant Ricardo Rodriguez, Jr., Hidalgo County Criminal District Attorney, files this Unopposed Motion for Extension of Time to file a Response to Plaintiffs' Second Amended Complaint for Injunctive and Declaratory Relief.

Plaintiffs filed their Complaint for Injunctive and Declaratory Relief on March 25, 2020 (Doc. 1), their Amended Complaint for Injunctive and Declaratory Relief on April 17, 2020 (Doc. 86).
