JOINT STATUS REPORT ON RISK-CORRIDORS CLAIMS

Plaintiffs Cigna Health and Life Insurance Company, Cigna Healthcare of Arizona, Inc., Cigna Healthcare of Illinois, Inc., Cigna Healthcare of North Carolina, Inc., and Cigna Healthcare of Texas, Inc. and Defendant United States of America respectfully submit this joint status report, as directed by the Court's July 1, 2020 order, regarding Plaintiffs' risk-corridors claims (Counts I and II). *See* Doc. 7 at 2.

The Court's July 1 order granted the Government's consent motion for a 30-day extension of time to respond to these claims, through today (August 5). As the Government's motion explained, the Supreme Court's recent decision in *Maine Community Health Options v. United States*, 140 S. Ct. 1308 (2020), "may entitle issuers to receive damages for unpaid risk-corridors payments," Doc. 6 at 2. The parties thus agreed to "use the requested 30-day extension to discuss a possible stipulation for entry of judgment to resolve counts I and II of the complaint," which seek recovery of such payments. *Id.* The parties have done so, but have not yet reached agreement. Thus, in accordance with the Court's instruction to "either: (1) file a joint stipulation for entry of judgment as to Counts I and II; or (2) file a joint status report proposing further proceedings," see

Doc. 7 at 1–2, the parties respectfully request an additional seven days, through and including August 12, 2020, to file a joint stipulation for entry of judgment as to Counts I and II.

On August 4 and 5, 2020, counsel for the United States authorized counsel for Plaintiffs to relay the United States's request for this seven-day extension and to file this joint status report.
