## STATEMENT OF ISSUES

Pursuant to this Court's order dated April 21, 2021, Defendants-Appellants hereby respectfully submit this Statement of Issues. The issues presented on appeal are:

1. Whether the religious-entity plaintiffs meet the requirements of standing and ripeness to seek a pre-enforcement injunction against the Department of Health and Human Services (HHS) based on the possibility that HHS might, at some time in the future, interpret the anti-discrimination requirements of Section 1557 of the Affordable Care Act to require that plaintiffs perform or provide insurance coverage for gender-transition services.

- 2. Whether the religious-entity plaintiffs meet the requirements of standing and ripeness to seek a pre-enforcement injunction against the Equal Employment Opportunity Commission (EEOC) based on the possibility that EEOC will, at some time in the future, bring an enforcement action under Title VII of the Civil Rights Act of 1964 to require that plaintiffs' health insurance plans cover gender-transition services.
- 3. Whether the district court abused its discretion by granting permanent injunctive relief against possible future enforcement of Section 1557 and Title VII in the manner plaintiffs fear, when plaintiffs have not demonstrated imminent irreparable harm.
