ORDER

This matter is before the court on Appellant Trinity Healthshare Inc.'s *Suggestion of Bankruptcy* filed in Appeal No. 21-1187, by which it suggests that Appeal No. 21-1187 and the underlying district court action were stayed by operation of 11 U.S.C. § 362 upon the filing of its bankruptcy petition in the U.S. Bankruptcy Court for the District of Delaware on July 8, 2021, Bankruptcy Case No. 21-11001. The court construes the suggestion as a motion to abate proceedings. Appeal Nos. 21-1185, 21-1186, and 21-1187 are consolidated appeals. It appears that the automatic stay applies to Appeal No.

21-1187, and that these consolidated appeals should be abated. Accordingly, **on or before July 27, 2021**, all parties are directed to file a response to the suggestion. If any party does not file a response, the non-response will be construed as consent to abatement.
