Defendants appeal the district court's judgment granting plaintiff a permanent injunction to prohibit defendants from enforcing the "Tax Mandate" of the American Rescue Plan Act. Plaintiff moves for expedited briefing, proposing an 11-10-11 day schedule, and expedited submission, argument, and decision by November 1, 2021. Defendants respond in opposition. Plaintiff replies.
