Appellees George Kelly III and Thomas Boogher, individually and on behalf of all others similarly situated, respectfully move this Court to dismiss the appeal brought by Appellant, the Aliera Companies Inc.

On October 14, 2021, Appellant's counsel, Burr & Foreman, LLP moved to withdraw as counsel. This Court granted that motion on October 15, 2021. As of today, Appellant is not represented by counsel.

Aliera, a corporation, can only appear in federal courts by and through licensed counsel. *Rowland v. Cal. Men's Colony, Unit II Men's Advisory Council*, 506 U.S. 194, 201-02 (1993); see also United States v. Van Stelton, 988 F.2d 70, 70 (8th Cir. 1993) (holding that Van Stelton was "not a party to this appeal because it [was] not represented by counsel and a corporation cannot appear *pro se*.").

Pursuant to the rules of this Court, 8 Cir. R. 3C and FRAP 3(a)(2), "an appellant's failure to take any step other than the timely filing of a notice of appeal . . . is ground only for the court of appeals to act as it considers appropriate, including dismissing the appeal." Appellant is not a

party to this appeal since it is not represented by counsel. Appellant's appeal should be dismissed for want of prosecution.
