ORDER

These consolidated appeals are before the court on the joint status report filed by Plaintiffs-Appellees and Defendant-Appellant OneShare Health, LLC. The parties reiterate that Defendant-Appellant Trinity Healthshare, Inc. has been dissolved as a matter of law under its bankruptcy court-approved liquidation plan, and report that bankruptcy counsel for Defendant-Appellant The Aliera Companies, Inc. has represented that it will also file a plan of liquidation and has obtained an extension of the exclusivity period through September 14, 2022 to do so. OneShare further reports that, until a

liquidating plan is proposed and confirmed, there remains the possibility that Aliera will emerge from bankruptcy and proceed in this litigation.

Upon consideration, the abatement of these appeals is continued. On October 7, 2022, or within 5 days of an order affecting the abatement of these appeals, the parties shall file a joint status report captioned for all three appeals advising the court as to the status of Aliera's bankruptcy proceedings.
